### **Questions and answers**

Q: How long does On-the-Job Training last?
A: The average length of an OJT is six months. Training length is based on the vocational preparation needed for the career and the current skill sets of the OJT employee.

**Q:** How much do I get paid?

**A:** Pay is determined by the type of job and current regional labor market. Pay rates are the same as for non-OJT employees.

**Q:** What kinds of positions are eligible?

**A:** Full-time occupations with growth potential that result in permanent employment. For example: office manager, bookkeeper, machinist, and mechanic, to mention a few.

**Q:** What employer can provide me OJT? **A:** An Alaskan employer in good standing with the State of Alaska who has a job opening for a skilled worker and hasn't recently relocated to the area.



## **Guidance for EMPLOYEES**

# What is On-the-Job Training (OJT)?

On-the-Job Training is an excellent opportunity for both employers and job seekers. With OJT, you, the trainee, will participate in hands-on training in an earn-while-you-learn work setting.

This specialized training allows you to develop skills and gain experience to enable advancement in your current career or perform a job in your desired industry.



#### **Benefits of OJT**

OJT benefits the employer, the employee, and the community. For you, the employee, it provides:

- Immediate income and benefits as an employee versus trainee
- Valuable skills learned in a practical setting
- Permanent employment almost certain after training
- A relationship with a Career Development Specialist to assist with any training- or work-related problems

#### **Common OJT methods**

**Demonstration/instruction** — showing the trainee how to do the job. (A billing clerk may be shown how to enter data into a specific computer system.)

**Coaching** — a more intensive method of training that involves a close working relationship between an experienced employee and the trainee. (An automotive service technician may be assigned to a mechanic in order to learn more timely and efficiently.)

**Job rotation** – the trainee is given several jobs in succession to gain experience of a wide range of activities. (An administrative assistant may spend time as a receptionist, on the company switchboard, and in a data entry position as a part of their training.)

## What are the program requirements?

On-the-Job Training is an agreement made between an employer, an employee and the Alaska Department of Labor and Workforce Development. The employee/trainee agrees to:

- Follow your training plan to the best of your ability
- Make satisfactory progress in all parts of your training plan
- Care and maintain any tools or supplies provided to you
